2012 Futurity Rules Weanling Does, Wethers & Bucks

Note: DEADLINES WILL BE STRICTLY ENFORCED.

Make sure you meet the postmark deadlines

- 1. Any doe whose kids will be shown in the WCPGA Weanling Futurity must be nominated to the Futurity Chairman, Pam Beuder, postmarked no later than January 31, 2012. A nomination fee of \$5.00 must be included along with the doe's name and registration number and the name of the owner for each doe nominated. A late fee of \$7.50, postmarked no later than 2-16-12 will be accepted. All dates are final.*
- 2. Only kids born of nominated does and born between 2-1-12 and 3-31-12 may be sustained and shown in the respective Futurities.*
- 3. Any number of kids from the nominated doe's litter may be sustained by paying a separate sustaining fee for each. NOTE: Specific kids do not have to be selected at this time, only the number of kids from the kidding you wish to sustain, noting whether they are does, bucks or wethers.*
- 4. The initial sustaining fee of \$5.00, multiplied by the number of kids to be sustained, must be received by the Futurity Chairman postmarked no later than 4-15-12. A late fee of \$7.50 for bucks, does and wethers, postmarked no later than 4-30-12 will be accepted. All dates are final.*

5. *The final sustaining fee of \$5.00 for each kid must be postmarked by 4-30-12. A late fee of \$7.50 for bucks, does and wethers, postmarked no later than 5-15-12, will be accepted. All dates are final. After April 30, 2012 each doe, buck or wether sustained will have to be identified by their registered herd and name (ie., registration papers will have been sent into NPGA)*
6. *All Weanling Futurity entries will show in the Weanling Futurity Baby Doe Kid, Weanling Futurity Baby Buck Kid or Weanling Futurity Baby Wether Kid classes on 5/26/2012 show. Original registration papers for does, bucks and wethers will be required to be checked by the show Chairman prior to admission to the Futurity Class. All Futurity entries must be tattooed or microchipped.*
7. *Only original NPGA registration papers will be accepted and entries will be judged according to the NPGA Breed Standard.*
8. *Sustaining fees collected will be divided and paid as premiums to the top five Futurity placements in the following increments:
1st - 30% 2nd - 25% 3rd - 20% 4th - 15% 5th - 10%
(Fees collected for does divided among does only; fees collected for wethers divided among wethers only; fees collected for bucks divided among bucks only)(Initial doe nomination fee will go to WCPGA for expenses incurred for Futurity)*
9. *After initial entry, there shall be no refunds for withdrawal for any reason. If the fees are not paid on time, the entry will be disqualified and fees forfeited. The only exception is in the event the show is not held, in which case the Futurity will be canceled and all fees returned to the entrants, minus any Futurity expenses already incurred.*
10. *If the nominated doe or any kid is sold, its Futurity rights continue to the new owner subject to the foregoing rules. Premiums will be paid to the owner at the time of the show as verified by registration papers.*
